## 6. Accidental release measures

**Personal precautions, protective** Avoid build up of vapor. Ensure sufficient supply of air. Avoid contact with eyes or skin.

Use appropriate techniques such as applying non-combustible absorbent materials or pumping. Where feasible and appropriate, remove contaminated soil. Place contaminated materials in disposable containers and dispose of in a manner consistent with applicable regulations.

## 7. Handling and storage

<b>Precautions for safe handling:</b>	Containers, even those that have been emptied, may contain explosive vapors. Do NOT cut, drill, grind, weld or perform similar operations on or near containers. Electrostatic discharge may be generated during pumping - this may result in fire. Ensure electrical continuity by bonding and grounding (earthing) all equipment.
<b>Conditions for safe storage, including any incompatibilities:</b>	Do not store in open or unlabeled containers. Store in a cool, dry place with adequate ventilation. Keep away from open flames and high temperatures.
<b>Storage regulation</b>	Container is not designed to contain pressure. Do not use pressure to empty container or it may rupture with explosive force. Empty containers retain product residue (solid, liquid, and/or vapor) and can be dangerous.
